## **RESOLUTION NO. BR2023-11**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BLUE RIDGE, GEORGIA GRANTING A VARIANCE FROM SECTION 140-508 ("OFF-STREET **AUTOMOBILE** PARKING") OF THE CODE OF ORDINANCES OF THE CITY OF BLUE RIDGE GEORGIA ("CODE") TO PERMIT FIFTEEN (15) PARKING SPACES WHERE TWENTY- SIX (26) PARKING SPACES WOULD OTHERWISE BE REQUIRED BY THE CODE FOR THE PROPERTY LOCATED AT 2290 EAST FIRST STREET AND **IDENTIFIED AS TAX PARCEL BR04-021-02.** 

WHEREAS, the property described in Exhibit "A" is zoned C-2 ("Community Commercial District"); and

WHEREAS, the applicant Fannin County Board of Commissioners is requesting a variance from Section 140-508 ("Off-Street Automobile Parking") of the Code to permit fifteen (15) parking spaces where twenty-six (26) parking spaces would otherwise be required by the Code; and

WHEREAS, following proper notice, the City Council held a public hearing as provided by law: and

WHEREAS, the City Council finds the application meets the criteria set forth in the Code for the approval of variances.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Blue Ridge that:

Section 1. The application for a variance from Section 140-508 ("Off-Street Automobile Parking") of the Code to permit fifteen (15) parking spaces where twenty-six (26) parking spaces would otherwise be required by the Code is hereby granted.
